Glacial Lakes Corn Processors and Glacial Lakes Energy, LLC fiscal year ends August 31, 2003. At this time, GLCP members who have not delivered their committed bushels will be invoiced the pool fee charge of \$0.04 per bushel. The pool fee covers the expenses of the agent to procure corn in the member's behalf for the fiscal

year. Pool fees must be paid prior to distribution of dividends to members.

Should you be intending to deliver committed bushels, you must contract and deliver prior to August 29, 2003; deliveries/contracts made after that date will be applied to next year's commitment. If you are not sure what you have delivered or are interested in contracting corn, contact Jack or Laurie at Glacial Lakes Energy.

GLCP members who have purchased distiller's grains in the past fiscal year are eligible for a two percent end-of-the-year discount. A refund for previously purchased and paid for distiller's grain will be distributed promptly after the fiscal year end of August 31 as well.


Recently, Glacial Lakes Energy, LLC made some site improvements including asphalting the roads within the plant and installing a security fence around the front perimeter of the plant. Paving the roads helps control dust emissions as well as helping with controlling plant cleanliness. The fence provides for added security for both the property and the employees.

Just a friendly reminder that the speed limit within the plant perimeters is 10 mph! We ask for your cooperation in obeying this limit for everyone's safety and well-being.

Support the ethanol industry as well as our plant by using ethanol blended fuel. If you have a flex fuel vehicle, we urge you to use E-85 which can be purchased at the Ampride gas station located on Broadway Street (across from the Guest House) in Watertown.
